In order to process your street pole banner request, you must include the following:

1. A written request on your organization's letterhead addressed to Commissioner Al Sanchez, Department of Streets and Sanitation, Bureau of Electricity, 2451 S. Ashland Avenue, Chicago, Illinois 60608. Your written request must include the event or organization to be recognized on the banner, the date of the event, and any other significant aspect to your request.
2. A completed Banner Permit Application.
3. A copy of the proposed banner's graphics.

Requests that do not include, and comply with, all three of the above requirements are not acceptable.
